CONSORTIUM






CONSORTIUM is a temporary statutory association of companies, which is formed for its members to achieve a joint economic goal and shall be registered subject to the Ukrainian legislation

- ➤ Bidding in the form of consortium enables the companies to demonstrate their compliance with the client's requirements to their advantage as the accumulated experience of completed projects, financial performance, etc. are evaluated
- ➤ The consortium bears joint and several proprietary liability, yet its member companies are liable for the consortium's obligations only within their shares unless the consortium's statute stipulates otherwise
- ➤ The consortium provides flexible legal opportunities to mobilize diverse investment resources, accumulate them, and transform into a productive capital
- Companies can be members of several consortiums
